## **ENGINEERING DESIGN**

Design and Installation of an Air Stripping System (AirSS) Sandwich Isles Communication Field Site, Oahu, Hawaii

CP&E, as a subcontractor to Greenwave Solutions Inc., was contracted to design all aspects of the AirSS to remove 99% of the Trichloroethylene (TCE) in the drinking water well. Design was for treatment of an average of 1 million gallons per day. In general, water treatment components consisted of two air stripping towers, well pump, granular activated carbon (GAC) vessel for air scrubbing, 50,000 gallon water storage tank, 5,000 gallon intermediate raw water tank and pumps, control building, and miscellaneous site improvements. Contract Amount: \$3.5 Million



## **CONSTRUCTION MANAGEMENT**



East Kapolei I Development, Kapolei, Oahu, Hawaii

CP&E was retained by State of Hawaii Department of Hawaiian Home Lands (DHHL) to provide construction management services for the East Kapolei I Residential Development including not only the 403-lot residential subdivision, but also the extension of Kapolei Parkway from the Kapolei Bridge to the intersection of North-South Road; an off-site trunk sewer that accommodates East Kapolei I and II developments, UH West Oʻahu Campus, D.R. Horton's development; and the 4.0 million gallon 215' water reservoir and transmission main. Specific duties included ensuring construction efforts

were performed according to final design plans and specifications and within schedule and budgetary guidelines; planning, directing, and coordinating activities concerned with the construction and maintenance of structures, facilities, and systems; overseeing the preparation of construction documents; reviewing cost estimates; bidding; negotiating; subcontractor selection; material purchasing; scheduling; project budgeting; building code compliance; project development; and quality control. Estimated Construction Cost: \$100 Million.

Ko Olina is a 640-acre world-class, master planned resort featuring 4,000 luxury hotel and condominium units, four man-made lagoons, 8,700 residential units, an 18-hole golf course, and a marina with 270 full-service slips.
